Horizon Housing Development Company would like to highlight one of our amazing consumers who originally moved into our Horizon North Program on 7/8/2022, then moved to our Horizon Housing program on 10/4/2023. Below our consumer explains her journey within the HHDC program and her amazing successes:

“In 2022, I moved into Horizon Housing during one of the hardest seasons of my life. I came in with just my job, my family, and a determination to rebuild after being down on my luck. Soon after, I faced even more adversity going through a divorce, transitioning into a new chapter, and becoming the full-time custodial parent of my son

Even in the midst of these challenges, Horizon Housing became the stable foundation I needed. With the support of the most amazing caseworker, who consistently connected me to resources, guidance, and encouragement, I was able to not only survive but truly grow into my potential.

During my time here, I’ve had the opportunity to accomplish things I once couldn’t even imagine. I graduated from Women in Leadership, moved from organizer to Director of Organizing at Bridge 2 Hope Parent Institute, contributed to WePower’s Community Wealth Building Design Playbook, became a Block Captain with the Federation of Block Units in The Ville, and served as a strong advocate for tornado recovery, housing justice and social justice in my community. Most importantly, I completed my first-time homebuyer’s program, and now I’m preparing to move forward into my next chapter as a homeowner.

Horizon Housing was exactly the program I needed. It gave me stability, dignity, and room to rise. I came in from the streets, uncertain and struggling—and I am leaving successful, confident, and empowered. I am forever grateful for this program and the people who poured into me. Horizon Housing didn’t just give me a place to live. It helped me rebuild my life.”

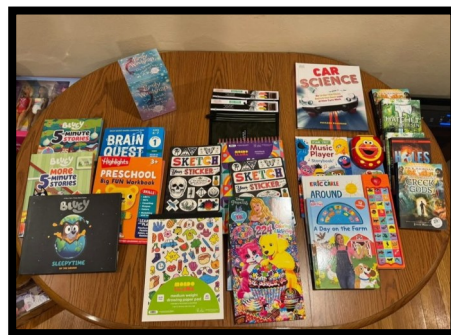
THANKSGIVING BASKETS
